Due to the high cost of insurance, North Hills Youth Football Association can only offer secondary insurance coverage to your child. In case of injury, the parents/guardians will be required to use their own insurance.

I/We the parents/guardians have read, fully understand and agree to the above. It is also understood that no moneys submitted to the North hills Youth Football Association will be refunded once the team roster is sent into the league. Following the North Hills School District policy pertaining to improper use of language or demeanor, (i.e., abusing, obscene or disrespectful language or gestures,) adults must conduct themselves in a respectable manner that provides a good example for the youth of our organization. Disrespectful conduct towards officials, coaches, other parents, or children will not be tolerated and will result in disciplinary action deemed appropriate by the officers and board members of the North Hills Youth Football Association. I/We the parents/guardians also agree to participate in the mandatory fundraisers. I/We the parents/guardians are also required to work the concession stand. I/We the parent/guardian of a football player(s) also agree to have a physical completed and form signed by the first day of practice and understand my child will not be able to practice until it is completed and returned.
